**PINAL COUNTY ANIMAL CARE AND CONTROL
ORDINANCE # 71395**

1004.A: IT SHALL BE UNLAWFUL TO KEEP, HARBOR OR MAINTAIN A DOG WHICH BY FREQUENT OR HABITUAL BARKING, HOWLING, SCREECHING, YELPING, OR BAYING OR IN ANY WAY OR MANNER INJURES OR DISTURBS THE QUIET OF A REASONABLE PERSON OF THE COMMUNITY, OR WHICH DISTURBS OR ENDANGERS THE COMFORT, REPOSE OR HEALTH OF A REASONABLE PERSON.

1007.A: NO DOGS ARE PERMITTED AT LARGE.

1015.C: ANY PERSON OWNING OR HAVING CARE, CONTROL OR CUSTODY OF ANY ANIMAL SHALL PROVIDE:

1. THAT THE ANIMAL RECEIVES FOOD THAT IS FREE FROM CONTAMINATION AND IS OF A SUFFICIENT QUANTITY AND NUTRITIVE VALUE TO MAINTAIN THE ANIMAL IN GOOD HEALTH.
2. THAT POTABLE WATER IS ACCESSIBLE TO THE ANIMAL AT ALL TIMES, EITHER FREE-FLOWING OR IN A CLEAN RECEPTACLE.
3. EXCEPT FOR LIVESTOCK, ALL ANIMALS SHALL HAVE CONVENIENT ACCESS TO NATURAL OR ARTIFICIAL SHELTER. ANY SHELTER WHICH DOES NOT PROTECT THE ANIMAL FROM TEMPERATURE EXTREMES DOES NOT COMPLY WITH THIS SECTION. ALL SPACES ACCESSIBLE TO THE ANIMAL SHALL BE MAINTAINED IN A MANNER WHICH MINIMIZES THE RISK OF THE ANIMAL, CONTRACTING DISEASE, BEING INJURED, OR BECOMING INFESTED WITH PARASITES.
4. THAT THE ANIMAL RECEIVES CARE

AND MEDICAL TREATMENT FOR INJURIES, PARASITES AND DISEASES, SUFFICIENT TO MAINTAIN THE ANIMAL IN GOOD HEALTH AND MINIMIZE SUFFERING.
