

INSTRUCTIONS -- AGREEMENT

1. The trap is to be placed only on the property of the person borrowing the trap.
2. The trap is to be used with bait placed inside the trap. Bait is not to be placed leading to the trap so as to entice animals.
3. The trap must not be placed in such a way that animals caught in the trap would be exposed to excessive heat from the sun.
4. The trap must be checked every four hours during the day.
5. All animals caught in the trap must immediately be turned over to Clark County Animal Control.

In consideration of the use of the animal trap(s), it is hereby agreed:

Indemnitor undertakes to indemnify and defend Indemnitee from any and all liability, loss or damage Indemnitee may suffer as a result of claims, demands, costs or judgments against it arising out of negligent use of the above referenced animal trap(s), whether the liability, loss, or damage is caused by, or arises out of the negligence of Indemnitee or Indemnitee's agents or employees. Indemnity under this agreement shall begin on _____ and continue until the trap is returned. Indemnitee agrees to notify Indemnitor in writing, within 30 days, by registered mail, at Indemnitor's address as stated in this agreement of any claim against Indemnitee on the obligations indemnified against.

If above mentioned trap is lost, damaged, or stolen, the Indemnitor agrees to be responsible for the cost of the replacement.
