QUARANTINE PROCEDURES

YOUR ANIMAL WILL BE TRANSPORTED TO THE WACO HUMANE/SHELTER 2032 CIRCLE ROAD, 754-1454, FOR A QUARANTINE PERIOD OF (10) DAYS FROM THE DAY OF THE BITE OR SCRATCH.

THE ANIMAL SHELTER WILL PROVIDE ADEQUATE FOOD, WATER, SHELTER, HUMANE CARE AND MINIMUM VETERINARY CARE IF NEED WHILE YOUR ANIMAL IS UNDER QUARANTINE.

THE ANIMAL SHELTER DOES NOT ACCEPT ANY RESPONSIBILITY FOR THE HEALTH OF ANY ANIMAL THAT IS NOT CURRENTLY VACCINATED FOR AIRBORNE DISEASES SUCH AS-- PARVO, DISTEMPER, UPPER RESPIRATORY INFECTION IN CATS, ETC.

THE OWNER IS GIVEN 48 HOURS FROM THE LAST DAY OF THE QUARANTINE PERIOD TO CLAIM THE ANIMAL AND PAY THE FEES. THE OWNER IS CHARGED BOARDING FEES FOR EACH NIGHT THEIR ANIMAL IS AT THE ANIMAL SHELTER. ANY ANIMAL NOT CLAIMED SHALL BECOME PROPERTY OF THE WACO HUMANE SOCIETY/ANIMAL SHELTER.
